ENTRANCE FEE AND PARKING NOTICE

WestWorld will charge \$5.00 per day for parking on Friday through Monday or an Event Pass will be available on Thursday for \$20.00 at HEADQUARTERS. EXPECT DELAYS!! Leave plenty of time to park, unload and get to your ring.

ALL SPECIALTY EXHIBITORS must park in the DAY OF SHOW PARKING which is located in the paved lot on the North side of the show grounds, except those who have paid for a reserved Motorhome space.

There will be NO PARKING OR UNLOADING in the RESERVED BERM PARKING on the SOUTH side of the rings. Violators will be towed at the owner's expense.

THE UNLOADING ZONE on the NORTH side of the rings may be used for UNLOADING ONLY. Vehicles must then be removed and parked in the DAY OF SHOW PARKING LOT.

DIRECTIONS TO SHOW GROUNDS

NORTH (Flagstaff)
I-17 on to SR-101 loop - Eastbound into Scottsdale. Take Pima/Princess exit. Make a left at Bell Road (second light) continue East on Bell Road. Turn right on 94th Street. Travel South to WestWorld Entrance. Turn right, follow road to Dog Show.

WEST (California)
I-10 East to SR-101 loop North (near Tolleson). Remain on SR-101 across I-17 continue into Scottsdale. Take Pima/Princess exit.
Make a left at Bell Road (second Light) continue East on Bell Road.
Turn right on 94th St. Travel South to WestWorld Entrance. Turn right follow road to Dog Show.

SOUTH (Tucson)
I-10 to SR-202 loop (San Tan Freeway). SR-202 East to SR-101 loop. SR-101 North to Frank Lloyd Wright Blvd exit. Move to far right lane and continue straight crossing Frank Lloyd Wright Blvd. intersection. Stay in right lane. WestWorld entrance is on top of hill, turn right at large horse statue, follow road to Dog Show.

EAST (Globe)
Take US-60 (Superstition Freeway) West to SR-101 loop. SR-101 North to Frank Lloyd Wright Blvd exit. Move to far right lane and continue straight crossing Frank Lloyd Wright Blvd intersection. Stay in right lane. WestWorld entrance is on top of hill, turn right at large horse statue, follow road to Dog Show.

Exit at the West end of WestWorld going North onto the 101 Freeway. Proceed to the Scottsdale Road exit, about 3 miles. Turn left (South) and proceed to just past Greenway Road, about 2 1/2 miles. Turn right (West) at the Shane Co. building onto Acoma. The Clinic is about 1 block on the left (South) side of the road.
